## **7** THE CHALLENGE

In accordance with the regulatory framework applicable to investment firms, investment firms are now categorized into three classes.

- Class 3 IF: small and non-interconnected investment firms.
- Class 2 IF: investment firms other than small and non-interconnected investment firms.
- Class 1 IF: large investment firms that are systemically important or are exposed to the same types of risks as credit institutions.

Each investment firm shall receive from their national authority the category it belongs to. Each category requires a specific reporting.

A significant transformation process is necessary for investment firms to be able to implement the IFR reporting:

- Learning and acquiring the proficiency in a lot of new concepts, technologies and tools;
- Adjusting the compliancy organization and the ICT infrastructure;
- Successfully producing the IFR reports.










## Figure 1: AREVIO IFR DEDITION








#### Figure 3:
